## 1.0 INTRODUCTION

Consultation with the Hornsby Shire community was undertaken to seek feedback on a proposed new off-leash dog park at Fagan Park, Galston. Council has previously prepared an Off-Leash Dog Park Strategy which identifies Fagan Park as a suitable site for a new dog park facility.

The purpose of this report is to outline the methods of engagement undertaken and report on the results and outcomes of the consultation.

## 2.0 SITE LOCATION

Fagan Park is a large regional park located at 50X Arcadia Road, Galston. The proposed off-leash dog park is located roughly in the centre of the park and is bounded by a dam to the east, vegetation to the north and west and a large open field to the south.

## 3.0 BACKGROUND

Fagan Park covers 55 hectares of parkland and provides a variety of features and attractions including play grounds, picnic areas, themed gardens, a heritage conservation area, bushland trails, an eco garden and unstructured open space. The Park is Crown Land under the care, control and management of Hornsby Shire Council. Fagan Park attracts visitors from across Sydney to enjoy the landscaped parklands, historic buildings and bushland areas.

In 2021 Council adopted an off-leash Dog Park Strategy that provides guidance on the development and operation of off-leash dog parks within Hornsby Shire. Extensive community consultation was undertaken



during development of the Strategy and the results of the consultation were used to guide the recommendations in the final Strategy.

A large grassy area was identified in the centre of Fagan Park as suitable for a new off-leash dog park facility. The site slopes to the east and consists of a large open lawn area. The remains of old timber fence posts are located along the south-eastern edge of the proposed site.

#### 4.0 CONSULTATION METHODOLOGIES

A Concept Plan was prepared for the proposed off-leash dog park and a community engagement program was undertaken between 21 November and 12 December 2023. Community engagement is important to the success of the new facility and Council engaged with the community through the following channels:

- Online feedback form
- Social Media
- Council's eNewsletter
- Direct mailout to adjoining neighbours
- Notices placed on site
- Notification to stakeholders including:
  - Friends of Fagan Park

- Site meeting with representatives of Hornsby Electric Model Flying Club

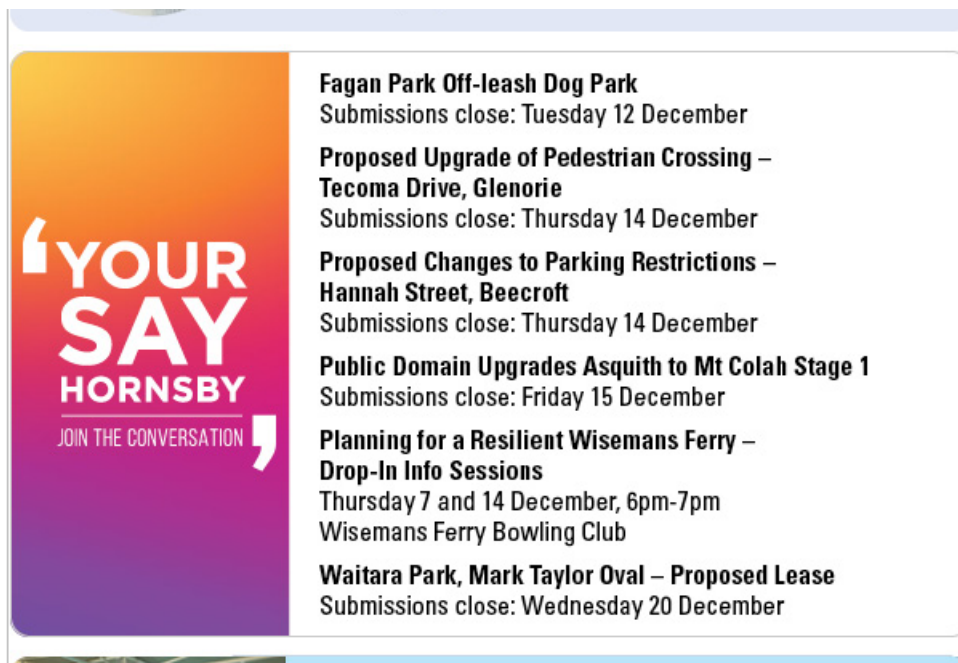

## 5.0 RESULTS

The community's interest in the Fagan Park off-leash dog park was evident with a total of 242 submissions received.

As indicated in Table 1 below, 64% of respondents indicated their support for the use of the area as an off-leash dog park and believe it will be a valued asset for the community. 15% were opposed to the proposal, 19% suggested alternative locations and 2% provided questions or comments of a general nature and did not indicate support or opposition to the proposal.

ISSUE/THEME	DETAILS	NUMBER OF SUBMISSIONS	RESPONSE
Shade/shelter	Request for the provision of shade, shelters and trees.	17	Council will provide trees for shade within the dog park.
Seating	Request for additional seating	11	Three seats were proposed on the Concept Plan. An additional seat will be added in response to community feedback.
Drinking water	Request for drinking fountains including dog water bowls at both entrances	11	One drinking fountain with a dog bowl will be provided at the top entry to the dog park. Due to the distance to a water source a drinking fountain is not proposed at the lower entry.
Garbage bins	Request for garbage bins and dog waste bags	5	Council will provide garbage bins with dog waste disposal bags at each entry to the dog park.
Public toilet access	Request for access to toilet facilities	4	There are three public toilet facilities provided at Fagan Park: <ul style="list-style-type: none"><li>• Arcadia Road entry</li><li>• Carrs Bush entry</li><li>• Close to the North American garden (closest option to the dog park)</li></ul>

Separate areas for small and large dogs	Request for separate areas for large and small dogs	29	Council is about to commence a trial of separate areas for small and large dogs at its off-leash dog park site at Greenway Park, Cherrybrook. The trial period will run for six months and if successful may be introduced at other sites.
Agility equipment	Request for agility equipment at the dog park	8	Providing play and agility equipment such as tunnels, jumps, boulders and other elements can enrich a dogs experience at the park when used correctly. However, in Council's experience agility equipment often falls into rapid decay from non or misuse and is actually used by very few people for their dogs.
Access to water play	Request for access to water for play	3	The dam at the base of George Hall creek on the eastern side of Fagan Park is considered unsuitable for water play due to potential impacts on bird habitat. In accordance with Council's Off-leash Dog park Strategy, no additional water play opportunities are proposed at the Fagan Park off-leash dog park.

Paid parking	Concern that paid car parking is prohibitive to regular users.	23	Income generated from the use of car parking facilities is an important source of funding for Fagan Park. Funds raised contribute to the maintenance and upkeep of the 55 hectare Regional Park. For residents of Hornsby Shire who wish to use the park on a regular basis an annual parking permit option is available which is less than \$1 per week.
Distance from car park facilities	Concern that the location of the dog park is not easily accessible from existing car parking areas.	9	There are two car parks available at Fagan Park. The Arcadia Road car park provides the most direct route to the off-leash dog park.
Distance from Galston town centre	The community noted that the proposed off-leash dog park was some distance from the Galston town centre and that many people using the facility would be required to drive there.	7	Fagan Park is located in a rural area and it is common for residents to drive to access facilities. Fagan Park is less than 1.5km from the town centre. The site was selected as the most suitable option available in the Galston area.
Increased parking demand	Potential increased demand for car parking	4	The supportive response received from the community indicates there is demand for a dog park facility and it is possible that visitation to Fagan Park may increase. As Fagan Park is Hornsby Council's premier regional parkland, visitation is encouraged. A large overflow car parking area is available onsite if required.

Impacts on wildlife	<p>Community members raised concerns over the potential impact on wildlife due the presence of dogs in the area. There was concern that the presence, scent and noise from dogs may deter native fauna from visiting the site.</p> <p>Concern was also raised over impacts on animals using the vegetation corridor to the north west of the dog park site and the potential loss of foraging ground for water birds who use the surrounding lawn areas.</p>	27	<p>Fagan Park covers 55 hectares including several water bodies and large grassy areas. The dog park will be fully contained within the lawn area only. The lawn area is subject to regular mowing.</p> <p>The off-leash dog park will cover less than 2% of the site and large areas of open grass remain available for birds and other animals.</p> <p>Dogs are currently permitted in Fagan Park when on a lead. Council will provide a fully fenced off leash facility with double gates at each entry. ## **7.0 RECOMMENDATIONS**

Based on feedback received from the community it is recommended that the off-leash dog park facility proceed with the following modifications.

- Dog park fence to be set back 20 meters from the adjacent dam to protect wildlife habitat.
- Dog park fence to be set two meters away from the north-western vegetation corridor to protect wildlife habitat.
- Undertake improvements to the access path connecting the Arcadia Road car park to the off-leash dog park.  
Shade trees to be provided within the off-leash dog park.
- One additional park seat to be provided within the off-leash dog park.

## **8.0 CONCLUSION**

Council's adopted Off-Leash Dog Park Strategy 2021 identified the Fagan Park site as suitable for an off-leash dog park facility. Extensive consultation with the community was undertaken during the development of the Strategy document.

Additional consultation with the community was undertaken specifically for the proposed off-leash dog park at Fagan Park in November/December 2023. The results reflect significant interest in and support for the project contingent on the provision of necessary protections to the environment, the provision of suitable access and amenity and ensuring that the existing character of the site is respected.
